2	Ceredigion Local Nature Partnership
	Terms of Reference
	Discussed proposed Terms of Reference. These have been circulated previously.
	JR – Gave in introduction to terms of reference and led a discussion. They should set out what CLNP is. Broader purpose of CLNP is to bring different nature recovery work together.
	Points discussed that may need changing –
	Natur Ceredigion – 'also known as Natur Ceredigion' JR – feels this could be better used as a hashtag in addition to full name, 'known informally as', not an alternative name. EE – Should be full Welsh name here, that would naturally get shortened. We need to make sure that the full Welsh name is given as much prominence as the full English name and that the Welsh name doesn't become shortened if the English name is being used in full. JW and DL – Concerns that this will be confusing as it stands. JW – 'Partnership' is the most important word so we shouldn't drop this. There are lots of other thigs in Ceredigion with the word Natur in the name but the partnership is what we should emphasise.

	Agreed Action—get rid of 'Natur Ceredigion' references as an alternative name in this document.
	Suggested – take out the sentence about the Grant Panel document. In grant information it makes sense to refer to the TOR but do we need to refer to grant documents here?
	Definitions –

Nature – check if this definition is a quote – where does it come from – add quotation marks and reference if it is.

EE- It doesn't contain the word habitat which is important.

BJ- It seems to imply that humans are separate from nature, not a part of it.

Action - If not a quote then maybe change it, simplifying the language. If it is then leave it.

Local Nature Partnership –

PNCNP-

EE – The full official names should be listed in both languages with equal status. Should include the word 'local'.

JW– Remove references to natur Ceredigion being used as an alternative name in rest of document.

LNPC - keep

NRAP -

JW- Could update the context to reflect more up to date targets – Kunming Montreal Global Biodiversity Framework. If there is a new version of the NRAP Wales by the time we adopt the TOR, we should change this, but the original wording refers to existing NRAP which although out of date now is the one being used so keep reference as is.

Aims

DL – suggestion to change 'people and organisations' to stakeholders

Approach

Suggestion - Change 'key organisations and individuals' to stakeholders and change last sentence 'partners and individuals' to stakeholders

Suggestion -change data sharing agreements section from participating authorities to 'participating stakeholders'

Status

Review this, but suggest get rid of the word 'must' could replace with 'are expected to' Could delete altogether.

Membership

Agreed action- Get rid of the 'adding their name' replace with 'a list of members will be kept securely by the host organisation'

About voting. Discussion, do we need it? Possibly there will be things to vote on. If we have this, do we need to say something about quorum?

Structure and responsibilities -

Responsibilities of members

Feedback/concerns – there is a big list of onerous jobs. Need to improve the way this comes across or it will put people off.

FM - Although these are all tasks for the partnership to undertake it may feel like each individual member would have to do all of these things which would be a full-time job.

Suggestion - Change the responsibilities to possibly remove 'regularly' and add 'for example' rather than a list of things you have to do as not every member can do all of this. Organisational partners would not be able to sign up to undertaking all of this

Meetings

Quorum.

Discussion about legal comments. Number of members/ quorum ratio.

Question from **DD** and discussion- What kinds of things will we be voting on? We should not be making political statements, consultation responses etc that a segment of the members would strongly agree with and a segment will strongly disagee with.

Action – Decide if we should put this in the TOR as a clear statement?

Change quorum to 5? Needs more thought/research.

Policies -

Assets -

Discussion about legal comments. There was agreement with Rachel's comments to legal about assets if the partnership dissolves. There must be a way to protect assets and but this may exist already in award letters.
